



RE: Equipment for City Clean-up

I have reviewed the information you shared regarding the Vigo County Solid Waste Management District's generous proposal to purchase equipment for us to use in an effort to aid in the beautification of the City of Terre Haute. As you are aware, we frequently assist Code Enforcement and other City departments with the abatement of a variety of situations. These include, but are not limited to, illegally dumped building materials, yard waste (to include grass clippings, dirt, wood waste and tree limbs), tires and garbage. It is typically necessary during City Clean-up days to utilize our chippers, dump trucks and front-end loaders to clear the wood waste, tree limbs, garbage and debris citizens have accumulated and/or stored for such events.

It is my belief the equipment, which would best assist us in serving the citizens of the City are as follows:

1. 2021 Hino 338 for approximately \$74,700
 - Outfitting for Hino 338 for our uses approximately \$44,211
2. 2021 Bandit Intimidator Drum Style Brush Chipper for approximately \$62,000
3. 2021 Bobcat T76 T4 Track Loader for approximately \$57,000
 - Brushcat brush cutting attachment for approximately \$6,439
 - Industrial Grapple Bucket for approximately \$3,661

Total: Approximately \$248,011

As mentioned above, we frequently use dump trucks and chippers to remove trash, wood and waste within the City. The addition of this chipper would allow us to commit a chipper and crew to City Clean-up days as well as to the needs of Code Enforcement and City Clean-up crews without requiring us to neglect our normal daily limb and wood waste abatement duties. In addition, I believe a skid steer loader would give us more flexibility and maneuverability when working to remove all manner of waste. A skid steer loader would allow us to get into more areas than we are able to utilizing our front-end loader and would be far less intrusive. Professionally,
