IT IS HEREBY ORDAINED by the Common Council of the City of Terre Haute that the Terre Haute City Code shall be modified as follows:

SECTION 1. Terre Haute City Code shall be modified with the insertion of the underlined text and deletion of the stricken text as follows:

CHAPTER 8: TRAFFIC & PARKING REGULATIONS

ARTICLE 1. TERRE HAUTE TRAFFIC CODE.

Division IV. One-Way Street Regulations.

Sec. 8-21 Specific One-Way Street Designations – Schedule E.

115	34th St.	S. 34th St.	Brown Ave.	Westbound

SECTION 2. The illegality or invalidity, for any reason, of any of the sections of this ordinance, or parts thereof, shall invalidate only such section or sections as are so determined to be illegal or invalid, any such invalidity shall have no effect on the remaining sections of this ordinance.

SECTION 3. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 4. This ordinance shall be in full force and effect from and after the date of its passage by the Common Council of Terre Haute, Indiana and approval of the Mayor and upon publication as required by law.

GENERAL ORDINANCE NO. 4, 2023

AN ORDINANCE AMENDING CHAPTER 8, SECTION 8-13, SIGNALIZED INTERSECTIONS – SCHEDULE D OF THE TERRE HAUTE CITY CODE.

IT IS HEREBY ORDAINED by the Common Council of the City of Terre Haute that the *Terre Haute City Code* shall be modified as follows:

SECTION 1. The *Terre Haute City Code*, Chapter 8, Section 8-13, Signalized Intersections – Schedule D, is hereby amended by insertion of the following signalized intersection:

CHAPTER 8: TRAFFIC & PARKING REGULATIONS

Sec. 8-13 Signalized Intersections – Schedule D.

SECTION 2. Due to the safety and increase in traffic volume at East Margaret Road and 4500 East Margaret Road a new traffic signal shall be located at the intersection of East Margaret and 4500 East Margaret.

SECTION 3. THEREFORE, BE IT ORDAINED by the Common Council of the City of Terre Haute that a new traffic signal located at the intersection of East Margaret Drive and 4500 East Margaret Drive shall be installed

SECTION 4. The illegality or invalidity, for any reason, of any of the sections of this ordinance, or parts thereof, shall invalidate only such section or sections as are so determined to be illegal or invalid, any such invalidity shall have no effect on the remaining sections of this ordinance.

SECTION 5. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. This ordinance shall be in full force and effect from and after the date of its passage by the Common Council of Terre Haute, Indiana and approval of the Mayor and upon publication as required by law.

SPECIAL ORDINANCE 2, 2023 - Vacating of an East-West Public Alley located south of 2425 1st Avenue (eastern four feet of Lot 217) through 920 North 25th Street <Garrison>

SPECIAL ORDINANCE NO.2. 2023

AN ORDINANCE VACATING A PORTION OF A PUBLIC ALLEY LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDERED by the Common Council of the City of Terre Haute, Indiana.

SECTION 1. Pursuant to the provisions of I.C, 36-7-3-12, it is desired and deemed necessary to vacate a portion of a public alley located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

Beginning at the Southeast corner of Lot 211 in Locust Street Subdivision as part of the Southwest Quarter (SW ¼) of Section 14, Township 12 North, Range 9 West, as per the recorded plat of the same, in Plat Record 6A, Page 79, recorded in the Office of the Recorder of Vigo County, Indiana; thence West along the South line of Lots 211, 212, 213, 214, 215, 216, and four (4) feet of Lot 217 in Locust Street Subdivision; thence due South fifteen (15) feet more or less to the North Lot Line of Lot 260 in Locust Street Subdivision; thence East along the North line of Lots 260, 261, 262, 263, 264, 265, and 266 to the Northeast corner of Lot 266; thence North to the Southeast corner of Lot 211, being the place of beginning.

SECTION 2. Be it further ordained that said portion of said alley in the City of Terre Haute, Indiana, above described, be and the same is vacated and will revert to the abutting properties, subject to the continuation of any and all existing easement rights for public utilities.

SECTION 3. Be it further ordained that the City Clerk be, and she is hereby directed to furnish a copy of this Ordinance to the Recorder of Vigo County, Indiana, for recording, and to the Auditor of Vigo County, Indiana.

WHEREAS, an emergency exists for the immediate taking effect of this Ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, and its approval by the Mayor and publication as by law provided.
