GENERAL ORDINANCE 3, 2024

AN ORDINANCE AMENDING CHAPTER 4 OF THE TERRE HAUTE CITY CODE RELATING TO AMBULANCE/EMS USER FEES.

SECTION 1. Terre Haute City Code, Chapter 4, Article 19. E.M.S. User Fees is hereby amended by deleting the stricken text and inserting the underlined test as follows:

Sec. 4-282 Ambulance/Medical User Fees Established.
