CITY CLERK

An Ordinance Amending Chapter 10, Article 2 of the Municipal Code designated as "Comprehensive Zoning Ordinance for Terre Haute Indiana."

SECTION 1. BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Vigo County, State of Indiana, that Chapter 10, Article 2 of the City Code of Terre Haute, designated as the "Comprehensive Zoning Ordinance for Terre Haute" and Division 4, Section 10.121 thereof, District Maps, be, and the same is hereby amended to include as follows:

"That the following described real estate situated in the City of Terre Haute, County of Vigo, State of Indiana, to-wit:

Lot Number 216 in Second Subdivision of Gilbert Place, Terre Haute, Vigo County, Indiana, Also, Lot Number 207 in the Replat of a part of Gilbert Place, a replat of Lots No. 1 to 12 inclusive and 21 to 24 inclusive in Gilberts 4th Subdivision and Lots 204 to 210 inclusive to Gilberts 2nd Subdivision to the City of Terre Haute, in Section 22, Township 12 North of Range 9 West of the 2d Principal Meridian.

Commonly known as: 1503 Ohio Street, Terre Haute, IN 47807 and 218 South 15th Street, Terre Haute, IN 47807

Be and the same is hereby established as a C2 Community Commerce District, together with all rights and privileges that may insure to said real estate and the owners thereof by virtue of the law in such cases provided, subject to all limitations and restrictions imposed thereon by deed or otherwise."

SECTION II, WHEREAS, an emergency exists for the immediate taking effect of this Ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, and its approval by the Mayor and publication as required by law.
