Nature of Complaint:

Over the past 3 months, I have observed and/or experienced **unusual electronic interference**, unexplained signal behavior, potential **radio frequency emissions**, and other abnormalities that strongly suggest the possible presence of:

- Unidentified radio or data-transmitting devices
- Surveillance or monitoring equipment not disclosed to me
- Interference with personal property or privacy
- Technology operating without consent or legal notice

I am concerned these devices may:

- Be used for **unauthorized surveillance or data interception**
- Be in **violation of federal communication laws (FCC)** or local ordinances
- Pose a threat to **privacy, health, safety, or civil rights**

Request for Action:

I respectfully demand that the Terre Haute Police Department and any appropriate authorities:

1. **Open an official investigation** into this matter.
2. **Dispatch a qualified technician or investigator** to inspect and document possible sources of the interference or suspicious equipment.
3. **Identify and disclose** any municipal, state, or federal equipment deployed in the area (if applicable).
4. **Remove or disable** any unauthorized or illegal devices found.
5. **Provide a written response** outlining any actions taken, findings, or next steps.

Additional Notes (Optional but Recommended):

- Specific devices or interference types observed:
 - sudden loss of signal in multiple phones, high-pitched sounds, equipment buzzing, thermal anomalies, etc. vulgar noises and voices, threats to leave apartment, constant attempted unwanted communications, clear and obvious signs of refusing communications, political phrases and speech, mentions of activist communities and racial remarks various repetitive phrases regarding those activist communities. Disturbance preventing me from doing my job properly, I have need to speak with any of these people causing these radio transmissions for any reason whatsoever, I have never consented to any conversations or use of any device to communicate with anybody concerning any of their discussions, multiple attempts to impersonate officers federal and local, the same people have communicated with individual involved with attacked my phone with injections and other hacking attempts, obvious stalking involved through mobile devices, this is obvious attempts or torture, harassment, threats
 - Times and dates of concern:
 - Entire stay in apartment beginning on July 5th multiple attempts for last 3 months
