SPECIAL ORDINANCE 6, 2025

AN ORDINANCE VACATING A PORTION OF AN ALLEY LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDAINED by the Common Council of the City of Terre Haute, Indiana:

SECTION 1. Pursuant to the Provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of certain public streets and alley ways located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:


Beginning at the Southwest corner of Parcel Number 84-06-27-476-005.000-002 (commonly known as 1519 Washington Avenue); thence East approximately 120' to the Southeast corner of the same Parcel; thence South approximately 15' to the Northeast corner of Parcel Number 84-06-27-476-010.000-002 (commonly known as 1457 South 16th Street); thence West approximately 120' to the Northwest corner of the same Parcel; thence North approximately 15' to the point of beginning.

SECTION 2. Be it further ordained that said portions of said alleyway in the City of Terre Haute, Indiana, above described, be and the same are vacated and will revert to the abutting properties, subject to the continuation of any and all existing easement rights for public utilities.

SECTION 3. Be it further ordained that the City Clerk be, and she is hereby directed to furnish a copy of this Ordinance to the Recorder of Vigo County, Indiana, for recording, and to the Auditor of Vigo County, Indiana.



PETITION FOR VACATION OF PUBLIC ALLEYWAY

TO THE PRESIDENT AND MEMBERS
OF THE COMMON COUNCIL OF
THE CITY OF TERRE HAUTE,
VIGO COUNTY, INDIANA

GENTLEPERSONS:

Petitioner, Jared Smith, owns or has an interest in the real estate described in Section 1 which is contiguous to the public ways described in Section 3, and as the owner of land abutting said public ways platted in the City of Terre Haute, Indiana, respectfully petition and request the legislative body of the City of Terre Haute, Indiana, to vacate these portions of the public ways described in Section 3 pursuant to the provisions of I. C. 36-7-3-12, and in support of this Petition would show to the Common Council of said City as follows:

1. Petitioner is the owner of the following described real estate located in Vigo County, State of Indiana:

Lot Numbers Twenty-three (23), Twenty-four (24), and Twenty-five (25) in Heinel's Subdivision of a part of Lots 1 and 2 in Deans Subdivision of that part of the South Half (1/2) of the South East Quarter (1/4) of Section 27, Township 12 North of Range 9 West lying East of the Wabash and Erie Canal in the City of Terre Haute, Indiana, as shown by the recorded plat thereof recorded in Plat Record 10, page 29, records of the Recorder's Office of Vigo County, Indiana.

Subject to easements, covenants, restrictions, leases and other matters of record affecting title to the subject real estate.

Subject to real estate taxes prorated to the date hereof.

2. That the following aerial photograph depicts the portion of the alley to be vacated:



3. That the portion of the public ways to be vacated as set forth above may be more particularly described as follows, to-wit:

Beginning at the Southwest corner of Parcel Number 84-06-27-476-005.000-002 (commonly known as 1519 Washington Avenue); thence East approximately 120' to the Southeast corner of the same Parcel; thence South approximately 15' to the Northeast corner of Parcel Number 84-06-27-476-010.000-002 (commonly known as 1457 South 16th Street); thence North approximately 15' to the point of beginning.

4. No landowner adjoining and abutting the public ways to be vacated would be adversely affected by the vacation of said public ways. To the knowledge of Petitioner, this portion of the alley has not been used as a public way for a substantial period of time, if ever.

5. Petitioner proposes the vacation of the public way in order to confirm existing uses of those public ways and to facilitate a proposed development project.

6. The proposed vacation would not hinder the use of a public way by the neighborhood in which the portions of the public ways to be vacated are located or to which they are contiguous. All other landowners in the area have and will continue to have direct access to public ways; and as set forth above, the proposed vacation of said portions of said public ways would not make access to any land by any person by means of a public way difficult or inconvenient; nor would said vacation hinder any member of the public's access to a church, school or other public building or place.
