SPECIAL ORDINANCE NO. 3, 2025

AN ORDINANCE VACATING A PORTION OF A PUBLIC WAY LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDERED by the Common Council of the City of Terre Haute, Indiana.

<u>SECTION 1</u>. Pursuant to the provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of a public way located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

In Block Number 26 in the Plat of Blocks Number 25-16-26 and 27 of the First Addition of Vandalia Park, located in the Southeast Quarter of Section 11, Township 2 North,

Range 9 West, Harrison Township, Vigo County, Indiana, as shown on the recorded plat thereof, recorded April 10, 1919, in Plat Record 12, Page 25, records of the Recorder's Office of Vigo County, Indiana:

Beginning in the South East corner of lot 857, South East to the North East corner of Lot 852, then West to the North West corner of Lot 852, then South to the South West Corner of lot 852, then West to the South East corner of lot 853, then North to the North East corner of lot 856, then to the place of beginning.

SECTION 2. Be it further ordained that said portion of said public way in the City of Terre Haute, Indiana, above described, be and the same is vacated and will revert to the abutting properties, subject to the continuation of any and all existing easement rights for public utilities.

<u>SECTION 3.</u> Be it further ordained that the City Clerk be, and she is hereby directed to furnish a copy of this Ordinance to the Recorder of Vigo County, Indiana, for recording, and to the Auditor of Vigo County, Indiana.

WHEREAS, an emergency exists for the immediate taking effect of this Ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, and its approval by the Mayor and publication as by law provided.

RESOLUTION 8, 2025 – Authorizing the filing of applications with the Federal Transit Administration <DeBaun>

RESOLUTION NO. 8, 2025

Resolution authorizing the filing of applications with the Federal Transit Administration, an operating administration of the United States Department of Transportation, for federal transportation assistance authorized by 49 U.S.C. Chapter 53; title 23, United States Code, or other federal statutes administered by the Federal Transit Administration.

WHEREAS, the Federal Transit Administrator has been delegated authority to award federal financial assistance for a transportation project;

WHEREAS, the grant or cooperative agreement for federal financial assistance will impose certain obligations upon the applicant, and may require the applicant to provide the local share of the project cost;

WHEREAS, the applicant has or will provide all annual certifications and assurances to the Federal Transit Administration required for the project;

NOW, THEREFORE, BE IT RESOLVED BY the Common Council of the City of Terre Haute, Indiana:

- 1. That the Mayor of the City of Terre Haute is authorized to execute and file an application for federal assistance on behalf of the City of Terre Haute with the Federal Transit Administration for federal assistance authorized by 49 U.S.C. Chapter 53, title 23, United States Code, or other federal statutes authorizing a project administered by the Federal Transit Administration, requesting Urbanized Area Formula Program assistance authorized by 49 U.S.C. 5307, either alone or in addition to other federal assistance administered by the Federal Transit Administration. The City of Terre Haute is the designated recipient as defined by 49 U.S.C. 5307(a)(2).
- 2. That the Mayor of the City of Terre Haute is authorized to execute and file with its applications the annual certifications and assurances and other documents the Federal Transportation Administration requires before awarding a federal assistance grant or cooperative agreement.
- 3. That the Mayor of the City of Terre Haute is authorized to execute grant and cooperative agreements with the Federal Transit Administration on behalf of the City of Terre Haute.
