SPECIAL ORDINANCE NO. 44, 2010

AN ORDINANCE AMENDING SPECIAL ORDINANCE NO. 22, 2009, AS AMENDED, TO AMEND THE SALARIES FOR THE POLICE DEPARTMENT FOR THE CITY OF TERRE HAUTE, INDIANA FOR 2010, TO TAKE EFFECT ON JANUARY 1, 2010.

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

SECTION 1. Pursuant to a Transit Utility arbitration award issued on November 12, 2010, and the "me too" clause in the collective bargaining agreement with the Police Department, the City is required to increase wages by 2.1%.

SECTION 2. Therefore, Special Ordinance No. 22, 2009, as amended, passed on September 10, 2009, is hereby amended by deleting the stricken text and inserting the underlined text as follows:

SECTION 1. Commencing January 1, 2010 the following salary schedule shall be in full force and effect for members of the Police Department of the City of Terre Haute, Indiana.

CLERK/TYPIST LEVEL I shall be paid an annual salary of ~~\$29,048~~ 29,658

SECRETARY LEVEL II shall be paid an annual salary of ~~\$30,430~~ 31,069

SECRETARY LEVEL III shall be paid an annual salary of ~~\$31,814~~ 32,482

PARKING VIOLATIONS CLERK shall be paid an annual salary of ~~\$29,048~~ 29,658

POLICE OFFICERS of the rank of Patrolman who have served less than one (1) year from the date of their respective appointments shall be paid an annual salary of ~~\$39,123~~ 39,945

POLICE OFFICERS of the rank of Patrolman who have served more than one (1) year from the date of their respective appointments shall be paid an annual salary of ~~\$42,088~~ 42,972

POLICE OFFICERS of the rank of Corporal shall be paid an annual salary of ~~\$43,612~~ 44,528 plus \$1,000 incentive allowance if working as a Detective.

POLICE OFFICERS of the rank of Detective shall be paid an annual salary of ~~\$43,612~~ 44,528 plus \$1,000 incentive allowance.

POLICE OFFICERS of the rank of Sergeant shall be paid an annual salary of ~~\$46,141~~ 47,110 plus \$1,000 incentive allowance if working as a Detective.

POLICE OFFICERS of the rank of Lieutenant shall be paid an annual salary of \$48,052 ~~49,061~~ plus \$1,000 incentive allowance if working as a Detective.

POLICE OFFICERS of the rank of Captain shall be paid an annual salary of \$50,135 ~~51,188~~ plus \$1,000 incentive allowance if working as a Detective.

POLICE OFFICERS of the rank of Assistant Chief shall be paid an annual salary of \$53,946 ~~55,079~~.

POLICE OFFICERS of the rank of Chief shall be paid an annual salary of \$62,245 ~~63,552~~.

SECTION 3. All other remaining section of the original salary ordinance shall remain unchanged.

SECTION 4. The illegality or invalidity, for any reason, of any of the sections of this ordinance, or parts thereof, shall invalidate only such section or sections as are so determined to be illegal or invalid, and any such invalidity shall have no effect on the remaining sections of this ordinance.

SECTION 5. All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.

SECTION 6. This amendment shall be in full force and effect from and after its passage and shall be effective as in the salaries provided on and for January 1, 2010.
