**SPECIAL ORDINANCE NO. 18, 2010**

AN ORDINANCE AMENDING SPECIAL ORDINANCE NO. 57, 2010, AS AMENDED, TO AMEND SALARIES WITHIN THE TERRE HAUTE PARK AND RECREATION DEPARTMENT, EFFECTIVE JANUARY 1, 2011.

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

SECTION 5. This amendment shall be in full force and effect from and after its passage and shall be effective as in the salaries provided on and for January 1, 2011.
