SPECIAL ORDINANCE NO. 3, 2011

AN ORDINANCE TO AMEND SPECIAL ORDINANCE NO. 37, 2011, AS AMENDED, SETTING THE SALARIES AND BENEFITS FOR CERTAIN EMPLOYEES OF THE CITY OF TERRE HAUTE, INDIANA, EFFECTIVE JANUARY 1, 2012.

WHEREAS, by Park Board Resolution No. 5, 2012, the Parks and Recreation Board has amended the position descriptions for the positions of Hulman Links Golf Pro and Rea Park Golf Pro to combine the positions and designate the position as Golf Operations Manager. In order to reflect such position changes and additional responsibilities, salaries must be amended.

BE IT ORDAINED by the Common Council of the City of Terre Haute:

SECTION 1. Special Ordinance No. 37, 2011, passed by the City Council on September 14, 2011, is hereby amended by deletion of the stricken text and insertion of the underlined text as follows:

RESOLUTION NO. 5, 2012


