**GENERAL ORDINANCE NO. 4, 2012  
AS AMENDED**

ORDINANCE TO AMEND GENERAL ORDINANCE 4, 2011, AS AMENDED, TO CHANGE THE COMPLETION DATE OF THE 5<sup>TH</sup> STREET TWO-WAY ROADWAY DESIGNATION.

WHEREAS, on June 9, 2011, the Common Council for the City of Terre Haute passed General Ordinance No. 4, 2011, as amended, to amend *Terre Haute City Code* Sec. 8-21, Specific One-Way Street Designations; and

WHEREAS, pursuant to General Ordinance No. 4, 2011, as amended, 5<sup>th</sup> Street is to be changed from a one-way street to a two-way street and such designation is to be effective June 1, 2012; and

WHEREAS, in order to complete this change to the 5<sup>th</sup> Street travel designation, four (4) pairs of traffic signals need to be installed at the intersections of 5<sup>th</sup> Street & Poplar Street, 5<sup>th</sup> Street and Walnut Street, 5<sup>th</sup> Street and Ohio Street, and 5<sup>th</sup> Street and Wabash Avenue. In addition, roadway re-paving will be completed on 5<sup>th</sup> Street from Poplar Street to Cherry Street, angle parking will be eliminated on 5<sup>th</sup> Street, re-painting of curbing, and striping of the re-paved roadway must take place; and

WHEREAS, the necessary improvements to complete the change of street designation will not be completed by June 1, 2012.

THEREFORE, IT IS ORDAINED by the Common Council of the City of Terre Haute that General Ordinance No. 4, 2011, as amended, is further amended to change the effective date of such roadway designation from June 1, 2012, to September 1, 2012.

WHEREAS, All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

WHEREAS, this Ordinance shall be in full force and effect from and after its passage by the Common Council of Terre Haute, Indiana and its approval by the Mayor and publication as required by law.
