GENERAL ORDINANCE NO. 14, 2012

AN ORDINANCE AMENDING *TERRE HAUTE CITY CODE* CHAPTER 2, ARTICLE 9, FUNDS AND FISCAL PROCEDURES, SEC. 2-123 TO TERMINATE THE FIRE DEPARTMENT NON-REVERTING REAL PROPERTY FUND.

SECTION 1. WHEREAS, the Fire Department Non-Reverting Real Property Fund was established in 2000 for the receipt of funds from the sale of abandoned Terre Haute Fire stations.

SECTION 2. WHEREAS, all abandoned fire stations have been sold and the City of Terre Haute does not anticipate the sale of any additional abandoned fire stations.

SECTION 3. WHEREAS, said Fire Department Non-Reverting Real Property Fund is no longer utilized or needed and should therefore be terminated and removed from the *Terre Haute City Code*.

SECTION 4. THEREFORE, BE IT ORDAINED by the Common Council of the City of Terre Haute that Chapter 2, Article 9, Section 2-123 of the *Terre Haute City Code* is hereby amended by deletion of the stricken text as follows:


~~Sec. 2-123 — Fire Department Non-Reverting Real Property Fund.~~

a. ~~That a special non-reverting operating account, entitled Terre Haute Fire Department Non-Reverting Real Property Fund, is established in the Terre Haute Fire Department for proceeds from the sale of abandoned Terre Haute Fire Stations.~~

b. ~~Funds from the Terre Haute Fire Department Non-Reverting Real Property Fund shall be used for purchase and repair of the real property dedicated to use by the Terre Haute Fire Department and shall be subject to appropriation by the Common Council of the City of Terre Haute, Indiana. (Gen. Ord. No. 5, 2000, 4-13-00)~~

SECTION 5. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

WHEREAS, an emergency exists for the immediate taking effect of this ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, Indiana and its approval by the Mayor and publication as required by law.
