

GENERAL ORDINANCE NO. 15, 2012

AN ORDINANCE AMENDING *TERRE HAUTE CITY CODE* CHAPTER 2, ARTICLE 9, FUNDS AND FISCAL PROCEDURES, SEC. 2-134 TO TERMINATE THE TELECOMMUNICATIONS NON-REVERTING FUND.

SECTION 1. WHEREAS, the Telecommunications Non-Reverting Fund was established in 2002 for the receipt of funds paid to the Data Processing Department from other City departments for telecommunications services.

SECTION 2. WHEREAS, such inter-departmental charges are no longer assessed by the Data Processing Department (Information Technology Department).

SECTION 3. WHEREAS, said Telecommunications Non-Reverting Fund is no longer utilized or needed and should therefore be terminated and removed from the *Terre Haute City Code*.

SECTION 4. THEREFORE, BE IT ORDAINED by the Common Council of the City of Terre Haute that Chapter 2, Article 9, Section 2-134 of the *Terre Haute City Code* is hereby amended by deletion of the stricken text as follows:

**Sec. 2-134 — Telecommunications Non-Reverting Fund.**

a. — ~~A special non-reverting telecommunications operating account, entitled Telecommunications Non-Reverting Fund, is established in the Data Processing Department and shall be funded by monies from other City departments paid to the Data Processing Department for telecommunications services.~~

b. — ~~Such funds shall be used for the purchase and maintenance of telecommunications equipment and services to establish communications systems throughout the City of Terre Haute departments.~~

c. — ~~Expenditure of funds shall be subject to appropriation by the City Council prior to expenditure. (Gen. Ord. No. 27, 2002, 12-12-02)~~

SECTION 5. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

WHEREAS, an emergency exists for the immediate taking effect of this ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, Indiana and its approval by the Mayor and publication as required by law.
