RESOLUTION NO. 14, 2012 AS AMENDED

A RESOLUTION AUTHORIZING THE ESTABLISHMENT AND CERTIFICATION OF "THE HAUTE ARTS CULTURAL DISTRICT."

WHEREAS, a cultural district may be designated to assist the district and community in developing public-private partnerships to support said district; and

WHEREAS, the City of Terre Haute seeks to establish such cultural district and such district shall be identified as "The Haute Arts Cultural District"; and

WHEREAS, Mayor Duke A Bennett supports the establishment of said cultural district; and

WHEREAS, the Indiana Arts Commission will be petitioned to designate said cultural district as a Statewide Cultural District.

NOW, THEREFORE, BE IT RESOLVED by the Common Council for the City Council that:

Section 1. The City of Terre Haute hereby establishes a cultural district and said district shall be identified as "The Haute Arts Cultural District."

Section 2. The Haute Arts Cultural District boundaries shall be defined as:

The southwest corner of 7th Street at Poplar Street, west on Poplar Street to 6th Street, north on 6th Street to Ohio Street, west on Ohio Street to 4th Street, north on 4th Cherry Street, west on Cherry Street to Center Street, north on Center Street to Spruce Street, east on Spruce Street to 7th Street, south on 7th Street to Eagle Street, east on Eagle Street to 9th Street, south on 9th Street to Cherry Street, east on cherry Street to CSX mainline tracks, south of CSX mainline tracks to Ohio Street, west on Ohio Street to 8th Street, south on 8th Street to Walnut Street, west on Walnut Street to 7th Street, south of 7th Street to Poplar Street.

Section 3. The Haute Arts Cultural District shall promote the exploration of and participation in the arts and humanities through cultural experiences unique to our community.

Section 4. The Haute Arts Cultural District shall endorse the goals of economic vitality and enhance community life through participation in the development and financial support of The Haute Arts Cultural District.

Section 5. The Haute Arts Cultural District shall encourage all residents of the City of Terre Haute, especially those who own property or businesses within said cultural district, to involve themselves and participate in the full development of The Haute Arts Cultural District.

Section 6. The Haute Arts Cultural District shall participate in the development of incentives to stimulate and encourage the vitality of said cultural district.

Section 6. The Common Council for the City of Terre Haute shall appoint one (1) city official to represent the City on the governing board of said cultural district.

Section 7. The Common Council for the City of Terre Haute encourages City staff to actively support and cooperate with the governing board to develop, maintain, and promote the economics of the arts and humanities in said cultural district.
