#### Greetings, John:

Please let this e mail serve as the necessary memo "detailing the need for this appropriation" per instructions @ the bottom of the Request For Additional Appropriation form. As Finance Chair you serve as the Redv Dept informal conduit to the rest of the Council regarding the Redv Dept request for "recapture" of EDIT monies expended by the dept in administering the unsafe bldg program for the City. I'm certain you & the mbrs of the Council remember my comments in recent months as I have come before the body requesting that the EDIT demo monies the dept collects (usually no more than 10% or so of yearly expenditures) from demo liens be reallocated to the mission of the unsafe bldg pgm to insure the ongoing activities of same. We are enjoying some success in our collection efforts the last 6 months & I hope it continues.

So, see above two requests for reallocation of said monies. Today we have received an additional \$10,627.00 & I will process a request for this money to be reallocated soon.

It is important to note that @ this time the Bldg Inspection Dept of the City Engineering Office has 294 condemned commercial & residential structures on the list! Our Redv Dept will conduct "hearings" for demolition on 50 condemned structures in early April with another 100 in the pipeline for hearings. In 2012 the Redv Dept on behalf of the City "demo'd" 65 residential bldgs, 2 garages, 3 commercial bldgs, 1 church, & cleaned, boarded & sealed 1 commercial bldg. Please know also, in our efforts to work with condemned bldg owners we sometimes have success in getting them to either rehab or demo the structures @ their expense. Of course, we do incur attorney & other legal fees.

With the above stated, I would appreciate the Council's acting favorably on this memo & two requests for additional appropriation. As always, thank you & your Council colleagues for your support of the Redv Dept in our mission.
