RESOLUTION NO. 3, 2015

A RESOLUTION RECOGNIZING LIEUTENANT HUGH G. CRAWFORD'S 35 YEARS OF SERVICE TO THE TERRE HAUTE POLICE DEPARTMENT.

WHEREAS, Hugh G. Crawford was assigned to the Uniform Patrol Division of the Terre Haute Police Department on December 5, 1979, where he later became a member of the Tactical Unit; and

WHEREAS, Crawford is a 1981 graduate of the Camp Atterbury Anti Sniper and Survivor School and a 1982 graduate of the Los Angeles Police Department SWAT School; and

WHEREAS, on July 1, 1983 Crawford was promoted to Detective and assigned to the THPD Investigation Division; and

WHEREAS, in less than a year with the THPD Investigation Division, Crawford was promoted to Detective/Corporal; and

WHEREAS, Crawford, affectionately known within the Department as "Mr. Whisper", served as a Sergeant in the Uniform Division and Investigation Division from 1987 through 1992, at which time he was promoted to Lieutenant and assigned a position as Shift Commander; and



WHEREAS, the Veterans of Foreign Wars Post 972 named Lt. Crawford "2014 Officer of the Year" in recognition of his efforts in implementing the School Protection Officer (SPO) Program in the Vigo County schools; and

WHEREAS, Lt. Crawford is highly regarded by his supervisors as a commander who will complete any task assigned, no matter how detailed or complicated; and

WHEREAS, Lt. Hugh G. Crawford has honorably served the citizens of the City of Terre Haute as a police officer for more than thirty-five (35) years;
