SPECIAL ORDINANCE NO. 38, 2016

AN ORDINANCE VACATING A PORTION OF STREETS AND ALLEYS LOCATED IN THE CITY OF TERRE HAUTE, VIGO COUNTY, INDIANA.

BE IT ORDAINED by the Common Council of the City of Terre Haute, Indiana:

<u>SECTION 1</u>. Pursuant to the provisions of I.C. 36-7-3-12, it is desired and deemed necessary to vacate a portion of certain public streets and alleyways located in the City of Terre Haute, Vigo County, Indiana, which is now laid out and existing in the City of Terre Haute, Indiana, and described as follows:

SEE EXHIBIT A.

<u>SECTION 2</u>. Be it further ordained that said portions of said streets and alleyway in the City of Terre Haute, Indiana, above described, be and the same are vacated and will revert to the abutting properties, subject to the continuation of any and all existing easement rights for public utilities.

SECTION 3. Be it further ordained that the City Clerk be, and he is hereby directed to furnish a copy of this Ordinance to the Recorder of Vigo County, Indiana, for recording, and to the Auditor of Vigo County, Indiana.

WHEREAS, an emergency exists for the immediate taking effect of this Ordinance, the same shall be in full force and effect from and after its passage by the Common Council of Terre Haute, and its approval by the Mayor and publication as by law provided.

GENTLEPERSONS:

Petitioner, Indiana State University, owns or has an interest in the real estate described in Exhibit A which is contiguous to the public ways described in Exhibit C, and as such owner or interested party respectfully petitions and requests the legislative body of the City of Terre Haute, Indiana, to vacate the portions of the public ways described in Exhibit C pursuant to the provisions of I. C. 36-7-3-12, and in support of this Petition would show to the Common Council of said City as follows:

- 1. Petitioners are the owners of or have an interst in the following described real estate located in Vigo County, State of Indiana (As of the filing of this Petition, Petitioner owns all of the abutting real estate except Tract A described in Exhibit C. Petitioner expects to complete the purchase of that tract before action on this Petition.): SEE EXHIBIT A
- 2. That Exhibit B discloses the portions of the public ways which Petitioner seeks to have vacated.
- 2. That the portion of the public ways to be vacated as set forth above may be more particularly described as follows, to-wit: **SEE EXHIBIT C**
- 3. No landowner adjoining and abutting the public ways to be vacated would be adversely affected by the vacation of said pubic ways; Petitioners are the owner(s) of or have an interest in all property adjoining and abutting the public ways to be vacated. To the knowledge of Petitioners, all of said pubic ways except Sycamore St. have not been used as public ways for a substantial period of time.
- 4. Petitioners propose the vacation of the pubic ways in order to confirm existing uses of those public ways and to facilitate a substantial proposed development project.
- 5. The proposed vacation would not hinder the use of a public way by the neighborhood in which the portions of the public ways to be vacated are located or to which they are contiguous since the Petitioner is the owner of all lands abutting said public ways. All other landowners in the area have and will continue to have direct access to public ways; and as set forth above, the proposed vacation of said portions of said public ways would not make access to

any land by any person by means of a public way difficult or inconvenient; nor would said vacation hinder any member of the public's access to a church, school or other public building or place.



Pursuant to I.C. 36-7-3-12, our office is notifying you of proposed street vacating and a proposed alley vacating. Enclosed is a copy of Special Ordinance 38, 2016 that vacates portions of Public Streets (Canal Street, Sycamore Street, Chestnut Street, and Water Street) and a portion of a North-South Public Alley located between Canal Street to the north, Eagle Street to the south, First Street to the east and Water Street to the west. These Public Streets and this Public Alley abuts your property located near Water Street and Sycamore Street as well as Canal Street, Terre Haute, Indiana (Parcel No. 84-06-21-503-003.000-002, 84-06-21-503-015.000-002, 84-06-21-503-012.000-002, 84-06-21-503-014.000-002, 84-06-21-503-015.000-002, 84-06-21-503-016.000-002, 84-06-21-503-017.000-002).

If you wish to be heard concerning this ordinance, it will be discussed during the Sunshine Meeting of the Terre Haute City Council on December 1, 2016. In addition, this matter will be discussed during the Regular Meeting of the Terre Haute City Council on December 8, 2016 as well as be acted upon. Both meetings are at 6:00PM in the City Courtroom located on the first floor of City Hall.
