**SPECIAL ORDINANCE NO. 1, 2017**

AN ORDINANCE TO FURTHER AMEND SPECIAL ORDINANCE 23, 2016, AS AMENDED, AN ORDINANCE SETTING THE SALARIES OF "CITY HALL" EMPLOYEES, EFFECTIVE JANUARY 1, 2017.

WHEREAS, Special Ordinance 23, 2016, AS AMENDED was passed on October 14, 2016; and

BE IT ORDAINED BY THE COMMON COUNCIL of the City of Terre Haute, Indiana:

**SECTION 1.** That Special Ordinance 23, 2016, AS AMENDED, is hereby further amended by addition of the underlined text and deletion of the stricken text as follows:




ordinance.


**SECTION 3.** All ordinances or parts of ordinances in conflict with this ordinance are hereby repealed.


