SPECIAL ORDINANCE NO. 13, 2017

AN ORDINANCE TO FURTHER AMEND SPECIAL ORDINANCE 23, 2016, AS AMENDED, AN ORDINANCE SETTING THE SALARIES OF "CITY HALL" EMPLOYEES, EFFECTIVE JANUARY 1, 2017.
