



FINDINGS and RECOMMENDATION

Staff Findings:

The proposed rezoning is in harmony with the Comprehensive Plan, and the Collett Park Vicinity Plan. The petitioned property is located within the South Neighborhood Subarea Plan, which has been envisioned an Assisted Living Community within this area. The building will be a 3 story residential care facility with 119 units and 64 parking spaces. The site is approximately 3.32 acres. A second entrance will be off N. 6th Street into the parking lot as platted on the site plan. A proposed detention area will be to the south of the parking area toward Locust Street.

The property consists of many already platted lots within the City of Terre Haute. A replatting of the properties to create a new legal description should be completed in a timely manner.
