There are several things going on along that stretch of Maple Ave. Joink, Vectren and our WWTP have been doing work up there. There was a broken sewer main that has been repaired. Vectren installed a new main and through fits and starts, that work and the patching is completed. Joink's work has also been completed. Most recently Vectren has installed service gas lines from the main to their customer's buildings. This is the only work, as far as we know, that remains. As an aside, we have told Vectren that we will not be issuing any new ROW permits until their current work in completed. They are under the gun to get their work completed before the asphalt plant shuts down for the winter.(~Dec. 8.)
