 - a. On the April 2017 Regular Agenda, the introducing councilmember was listed incorrectly for Special Ordinance 20, 2017. It has been corrected.
- 5. No Communications.
- 6. Reports from Governmental Agencies
 - a. Mayor Duke Bennett concerning Police and Fire Pension funds. Mayor Bennett responded that the retirees checks were on time. He responded that the budgets were created based on best estimates of the number of retirees and widows. Mayor Bennett responded the audit is on track and the city had asked the State Board of Accounts to audit 2016 while they were here. Mayor Bennett also commented the staff was working on a budget for the Redevelopment Commission. He responded that the pensioners health benefits are paid through the pension fund if funds available, if not the general fund. He also stated if the longevity or base pay for the police or fire increase, then the retirees receive the same increase. Mayor Bennett commented about the changes to the Indiana Code regarding road funding. He stated the amount of funds available should increase because of this change. Mayor Bennett answered Council President Nasser's question concerning Indiana Community Crossing Fund and the requirements. He stated Lafayette street should be at the top of the list for improvements if the funds come through.
 - b. Council President Karrum Nasser asked if pension fund payments were late to the retirees. He also asked how the budget was created for these funds. He asked the Mayor about the Indiana Community Crossing Fund. He also asked what streets would be most likely fixed first.
 - c. Councilman O. Earl Elliott asked the percentage of contribution by the city to the retirees fund. He also asked about the status of the audit. Councilman Elliott asked if the health benefits for the pensioners was paid out of the same fund as their retirement benefits. He also what would cause the monthly disbursements to increase for the retirement fund.
 - d. City Attorney, Eddie Felling, responded that the percent was 19% or 19.5%. He also responded that the percentage amount is announced by the state in the year prior to distribution. Mr. Felling stated next year's percentage is expected to be 17.5%. He also commented that the death of a retiree or surviving spouse will change the monthly disbursement in the pension fund.
