Hi Folks, it's me again. Last week was a tough week for all of you. Disappointing to some and a tough voting decision for others. This is not the time for gloating or pouting. We have a jail to build and we need to get on with it. We have all had situations in our jobs where we took one fork in the road and hit a dead end and had to go back and take another route.

That is where we find ourselves. We need to take another route. I hope we do not see legal action to overturn the rezoning vote because I am told that it would take six months and we do not want to lose any more purchasing power due to inflation.

As I have said before, most want the jail built near its

present location. Unless other land area opens up, the preferred design does not lend itself to this area. Therefore, I would again encourage you to move to the former Stu's golf course site. The schematic design prepared for the IP site will work just as well for the golf course with minor changes. It is also probably a much cleaner site. It's cost could be covered by the three months of increased LOIT that you did not anticipate plus eventual sale of the IP
