


From the Office of the Mayor

Statement on the Mayor's recent D.C. Trip

In an effort to voice concerns and opportunities for Terre Haute and West Central Indiana, Mayor Brandon Sakbun will be taking a short one-day trip to our nation's capital. The Mayor will be discussing a host of topics including but not limited to:

- 1. The Destination Wabash Project
- 2. Federal Railroad Elimination (Overpass) Projects and Grants
- 3. Support for veterans and the 181st Intelligence Wing
- 4. Interstate 70's long-term and short-term plan for funding
- 5. Infrastructure improvements regarding stormwater and wastewater

Mayor Sakbun plans to meet with several members of the Indiana Congressional Delegation along with officials from the Department of Defense and the Department of Transportation. Notably, the Mayor will meet with Transportation Secretary Pete Buttigieg during his visit.

"The city of Terre Haute will continue to advocate for itself in a bipartisan manner. I look forward to meeting with leaders from both sides of the aisle in an effort to elevate the city of Terre Haute. The administration

remains committed to working with the federal government to bring our tax dollars back here to the Hoosier state."

The Sewage Billing Department understands this and therefore, we offer what's called a Summer Allowance. For those who have lived at their residence for at least 12 months, you can apply for a possible credit to be posted to your account the following year. Please keep in mind that you are still responsible for the high bill(s) over the summer. <u>Click here</u> to complete our Summer Allowance form.

Recycling Rebates Available!

Do you currently have a recycling account with Republic Services? If your trash is included in your sewage bill, you could qualify for a 50% rebate on the trash portion of your bill. All you need to do is provide our office a copy of your most recent Republic recycling bill either in person or electronically to qualify for the quarterly rebate on your bill. To send your recycling bill electronically, our email address is sewagebilling@terrehaute.in.gov.

Location Location Location!

Did you know there are multiple ways and places you can pay your Sewage/Trash bill? The easiest way is to set up EZ-Pay. Use the information on your bill to go online and set it up today and save yourself the hassle. One great way to pay your bill is to bring it to our office, which is located on the 2nd floor of City Hall, at 17 Harding Ave, Terre Haute, IN 47807. Our office is open Monday through Friday, 8am to 4pm. You can even drop off your payment after-hours in our drop box, located at the West entrance of City Hall. Can't make it to our office, please <u>click here</u> for other payment locations. All bills are due on the 14th of every month, so mark your calendar today with a reminder.

Leaks happen! What to do you when you have one!

Leaks are a very common occurrence. The best way to be conscious of a leak is to look at the section of your bill that shows your usage. If ever there is a severe usage spike or growing usage trend, neither of which you can explain, that is a good indicator that you have a leak somewhere. The three steps to notifying our office of a leak are **Report**, **Repair, & Record.** Want to know more? <u>Click here</u> to learn how you can request consideration for a leak adjustment.

Need assistance paying your bill?

Are you or someone you know in need of assistance with their sewage bill? There is help available for those who qualify. One option is the *Indiana Emergency Rental Assistance Program*. They can be reached at 317-800-6000 or by calling 211. Another option is to contact your local Trustee's Office for guidance on utility assistance and how to qualify.

Own Rental Properties?

As a property owner, it is your responsibility to ensure the sewage/trash bills are paid for your rental properties. If these bills go unpaid, any balances can become a lien against the property. If the sewage bills are in your tenant's name, you

can check your tenant's account balances 24/7 on the City of Terre Haute Sewage Bill Records Portal. <u>Click here</u> to access this useful tool today!





If you sign up for curbside recycling with Republic, you are able to get a 50% rebate on the service that will be credited to your trash bill from the city.

Provide a copy of your recycling bill to Sewage and Billing to be opted into the rebate. For more information, contact them at 812-244-2343.






Upcoming Sidewalk Improvement Projects

WHAT IS AN ORDINANCE?

An ordinance is a law created by a local government, such as a city council or county board of supervisors. Local governments can only create laws on matters that the state government says they can.

TRASH ORDINANCE UPDATE FOR THE TERRE HAUTE SANITARY DISTRICT

The fee for the cost of "Waste and Refuse Collection and Removal for Residential Customers" is your monthly trash fee for your trash service.

Since 2019, the rate has been \$11.00. Beginning on July 1, 2024 this rate will increase. Each year, the rate will resume increasing ~3.3% as it did in the past. The rates will be evaluated every 3 years.

IF YOU ARE; Over 65, blind or disabled, a disabled veteran or a surviving spouse, and have filed and been granted a deduction on your property taxes by the <u>County Auditor</u>, you are eligible for a 33% monthly credit/discount on your bill.

Current & Scheduled Trash Fee Rates

July 1st, 2019	\$11.00 per month
July 1st, 2024	\$15.00 per month
July 1st, 2025	\$15.50 per month
July 1st, 2026	\$16.00 per month

With Available Credit Homeowner

July 1st, 2019	\$8.25 per month
July 1st, 2024	\$10.05 per month
July 1st, 2025	\$10.38 per month
July 1st, 2026	\$10.72 per month

The recycling rebate that is offered to city residents will be increased from 25% to 50%.



WHY THIS ORDINANCE?

This ordinance is aimed at enhancing the health, safety, and general welfare of our community through improved stormwater management. It is a step forward in protecting our waterways and ensuring a healthier environment for all.

UNDERSTANDING OUR GITY ORDINANGES ())

NEW STORMWATER MANAGEMENT IMPROVEMENT FOR TERRE HAUTE

Key components of the ordinance:

- Prohibition of Non-Stormwater Discharges
- Illicit Connections and Discharges
- Responsibilities for Industrial and Construction Activities
- Monitoring and Enforcement
- Best Management Practices
- Public Notification and Education
- Penalties for Non-Compliance
- Emergency Measures

WHY THIS ORDINANCE?

To reaffirm our commitment to ethical practices in public spending, ensuring that all city projects are carried out by responsible and qualified contractors.

UNDERSTANDING OUR



NEW CRITERIA FOR RESPONSIBLE CONTRACTORS BIDDING ON CITY PROJECTS

This ordinance applies to any city contract or service for public works costing at least \$150,000. Public works include construction, reconstruction, alteration, or renovation of public buildings, highways, streets, bridges, and other infrastructure.

Criteria for Bidders:

- Comply with all relevant laws
- Provide evidence of a federal employer identification number.
- Confirm non-discrimination practices.
- Provide certificates of insurance.
- Submit a statement on employee classification and drug testing plans.
- Disclose information about past legal violations, tax delinquencies, and previous project experience.
- Utilize approved apprenticeship programs.

OTHER ELEMENTS INCLUDE: Ensuring all subcontractors meet the criteria and submit necessary documentation before starting work, submitting weekly certified payroll reports, all submission and payroll reports will be public record and false information will result in consequences, procedures for not chosen bidders and ties, etc.
